The Guidelines for Intellectual Property and Personal Data Protection Committee of Chung Yuan Christian University

- Article 1 In order to implement and manage the intellectual property and personal data protection in Chung Yuan Christian University ("CYCU"), CYCU formulated the Intellectual Property and Personal Data Protection Committee ("The Committee").
- Article 2 The Committee comprised of thirteen (13) to fifteen (15) commissioners, one Executive Vice President, Vice President for Academic Affairs, Vice President for Student Affairs, Vice President for General Affairs, Secretary General, Dean of the Library, Vice President for Information Technology, Director of Human Resources, Vice President for Alumni Services and Resource Development, and the Vice President for Continuing Education serve as an ex-officio commissioner of The Committee. The chairperson of The Committee is appointed by the President, and the remaining commissioners are appointed by the President from among relevant experts or scholars if deemed necessary, of which legal professional and student representative shall be one of each at least, holds a term for one year.
- Article 3 The tasks of The Committee are as follows:
 - 1. Draw up policies, promote, and supervise the implementation of intellectual property and personal data protection in campus.
 - 2. Stimulate suggestions for campus network management and textbook photocopying management.
 - **3.** Stimulate suggestions for the intellectual property and personal data protection propaganda, educate and training.
 - 4. Assess and manage risks of personal data.
 - 5. Prevent the damage of personal data and deal with adaptable crisis.
 - **6.** Evaluate the intellectual property and personal data protection in campus, and ameliorate continuously.
- Article 4 The Committee shall convene one conference in every semester, extraordinary conference may be convened if deemed necessary.
- Article 5 The convening of The Committee conference requires the attendance of more than one half of the commissioners ; the resolutions can be made only with the consent of more than half of all the attendees presentation. Relevant personnel may be invited to participate if necessary.
- Article 6 The Guidelines is passed by the Administrative Meeting ; promulgated and implemented by the President, the amendment does as well.
